APPOINTMENT OF AGENT FOR
PROCUREMENT OF NATURAL GAS

RELIABLE CHOICE ENERGY, LLC, 5510 Cascade Road SE, Suite 130, Grand Rapids, MI 49546 ("Agent") provides professional services in natural gas procurement. ("MRA Member") wishes to retain Agent to perform such services and to authorize Agent to act on MRA Member's behalf for purposes of securing MRA Member's natural gas requirements as set forth herein. Agent agrees to accept such engagement under the terms and conditions set forth herein. The Parties hereto mutually consent, covenant, represent, warrant and agree as follows:

- 1. Agency Authorization. MRA Member hereby authorizes Agent to secure its natural gas requirements as set forth herein. As such, Agent shall have full authority to enter into contractual agreements pertaining to supply and/or delivery of natural gas to MRA Member's facilities. The term "delivery" as used herein, shall include interstate transportation of natural gas as well as delivery of natural gas through MRA Member's Local Distribution Company (LDC).
2. Term. The term of this Agreement shall commence on the date indicated above and shall remain in effect until terminated by either Party upon no less than sixty (60) days written notice to the other Party provided, however, that such termination shall not become effective until the expiration of any commitments made by Agent on behalf of MRA Member in accordance with the terms set forth herein. Commitments made by Agent to purchase natural gas supply shall commence no sooner than MRA Member's LDC billing cycle.
3. Facilities Served. Service hereunder shall be limited to MRA Member's facilities identified on MRA Member's Natural Gas Customer Choice Member Enrollment Form(s) as attached hereto.
4. Assignment. Agent shall have the right to assign this Agreement including its rights and duties hereunder to a third party provided however, that if assigned to any party other than a direct affiliate of Agent, MRA Member shall receive written notification from Agent including detailed information about the party to which such assignment is made.
5. MRA Member Rebate. Subject to (a) and (b) below, MRA Member shall be eligible for an annual rebate as set forth under the Michigan Restaurant Association's natural gas procurement program. The amount of such rebate shall be based upon MRA Member's actual consumption of natural gas hereunder during the 12 month period ending with MRA Member's utility billing cycle for the month of March. To qualify for this rebate, MRA Member must meet with the following criteria:
a. MRA Member must have been actively taking service under the MRA Natural Gas Customer Choice Procurement Program on or before July 1 of the preceding year.
b. MRA Member must be actively participating under the MRA Natural Gas Customer Choice Procurement Program at the time such reimbursement is to be made.

The amount of any rebate due to MRA Member will be paid annually on or about July 31.

- 6. MRA Membership Requirement. Agent's provision of service hereunder is available exclusively to members in good standing of the MRA. Any lapse in or cancellation of MRA membership shall result in a termination of service hereunder effective with the expiration of any then effective commitments already made by Agent on MRA Members behalf.
7. MRA Natural Gas Customer Choice Member Enrollment Form(s). This Appointment of Agent is attached to and made in conjunction with MRA Member's completed MRA Natural Gas Customer Choice Member Enrollment Form.
